RoHS 3 Compliance

Atlantex Manufacturing Corporation certifies that all of our products designated as RoHS Compliant conform to the requirements of EC Directive 2015/863/EU (RoHS 3). Directive 2015/863/EU (RoHS 3) includes the additional four Atlantex Manufacturing will continue to monitor the status of these Directives in order to meet any additional requirements. Compliance of Atlantex Manufacturing Corporation is maintained through strict control of our supply chain and input materials.

REACH Classification/ Substances of Concern

EC 1907/2006, released in June 2007, specifies duties and obligations regarding the Registration, Evaluation, Authorization, and Restriction of Chemicals (REACH) for companies in the European Union that manufacture or import substances either on their own, in preparations, or in articles. Per the structure of the REACH Regulation, AMC is a manufacturer and supplier of "articles," as we do not manufacture or supply "substances" or "preparations," and our articles do not involve the "intentional release of substances." As such, AMC does not anticipate any registration or pre-registration requirements for the articles we manufacture and supply. To the best of our knowledge, articles supplied by AMC do not contain Substances of Very High Concern (SVHC) as defined by REACH, and AMC does not specifically analyze for the presence of these substances.
